The Indiana Uplands is a federally recognized grape-growing region known as an American Viticultural Area, or AVA. Napa Valley in California is also an AVA. The 23rd annual Indy International Wine Competition was held July 30 through August 1. Nearly 3,000 entries from 15 countries and 40 U.S. states were evaluated. The Indiana Upland Wineries re-

ceived five double gold medals, 15 gold, 49 silver and 24 bronze. Jim Pfeiffer, owner of Turtle Run Winery in Corydon and president of Indiana Uplands, said, "This speaks of the quality of wines that we're producing collectively on the Indiana Uplands Wine Trail." The Indiana Uplands is comprised of Best Vineyards in Elizabeth, Butler Winery in Bloom-

ington, Brown County Winery in Nashville, French Lick Winery in West Baden Springs, Huber's Orchard, Winery and Vineyards in Starlight, Oliver Winery in Bloomington, Owen Valley Winery south of Spencer, Turtle Run Winery in Corydon, and Winzerwald Winery in Bristow. Utility Regulatory Commission Extends Seven-Digit Dialing In 812 Area Code

On Wednesday, the Indiana Utility Regulatory Commission (IURC) ordered that the permissive dialing period (i.e., seven digit dialing) for the 812 area code overlay remain in effect until otherwise ordered. Previously, the permissive dialing period was scheduled to run through September 5 with mandatory 10-digit dialing beginning September 6.

As a result of the IURC's order, customers can continue using seven-digit dialing when making local calls. Without this change, customers would have been required to use 10-digit dialing when making local calls starting September 6.

Recently, the IURC became aware of concerns regarding the

ability of critical segments of the business community and telecommunications providers to prepare for the switch to mandatory dialing, specifically those serving the medical and law enforcement industry. With safety being the utmost priority, the IURC has reopened the record in this proceeding to assure that public health and safety

concerns are addressed prior to mandatory 10-digit dialing going into effect.
